The Application of Group Relations in Family, Organizational, and Social Systems December 17-19, 2020



About Koodam¹

Koodam is envisaged as a gathering of practitioners of group relations work to further the thinking and practice in this field in a collegial space. We see this as an annual or biannual offering of Group Relations India (GRI), and offer with great pleasure – the second in the series!²

Group relations frameworks have drawn from and are a confluence of systems psychodynamics, socioanalysis, and psychoanalysis, particularly as applied to groups. They have also developed from the practice and innovation of people in different countries and particular contexts across the world.³ Among the various group relations organisations internationally, GRI is relatively young, but draws upon an impressive tradition of work in India since the early 1970s.

¹ Koodam is a Tamil word which means a space to gather. There are similar words in other Dravidian languages, signifying a space with some defined but not too rigid boundaries, inviting multiple uses and possibilities of what can happen and what may emerge.

² The first Koodam was held in April 2018 in Bengaluru, India.

³ Primary among these influences is the work done at the Tavistock Institute since the early 1950s which established the foundational constructs of group relations.

Koodam is a space to think about and explore together a range of ideas and issues pertaining to group relations such as:

- How do we understand the various concepts that build group relations frameworks?
- What does our practice mean? What is its relevance for application in various contexts?
- What dilemmas does it throw up? What challenges and opportunities does it offer in terms of conceptual and theoretical advances in the taking up of roles?
- How does it intersect, engage with, and learn from other traditions; where are the boundaries drawn, and why?
- How do group relations practitioners make sense of their contexts – personal, social, and professional, when using these frameworks?
- How would we want to shape group relations work in the future? What would we like to do within the space of GRI towards this?

The Primary Task of Koodam 2020 is to broaden and deepen one's thinking about the application of group relations frameworks in family, organizational, and social contexts, by offering one's thoughts and experiences towards generating insights through collective reflection.





Koodam 2020 is open to anyone who has had an experiential engagement with the group relations methodology through participation in a Group Relations Conference, or the Listening to the Unconscious workshop, or other similar learning experience and is interested in furthering their understanding and practice.

Design of Koodam 2020

Given the reality of COVID 19, *Koodam* 2020 is planned as an online event, spanning 12 hours over three days (four hours each day). There will be two interactive presentation slots of 75 minutes each, on all the three days, followed by a 45-minute reflection/exploration plenary session to wrap up the day. Each interactive presentation will be initiated by a presenter/or presenters, offering their thoughts on the theme and through this, stimulating further engagement and exploration.

Koodam 2020 is designed and managed by a convening team comprising of Ganesh Anantharaman, Rosemary Viswanath, Vartika Jaini and Veena Pinto. We have invited two speakers to present. The other four presentation slots are open to those interested in presenting on a topic related to the theme. If there are several potential presenters, we will plan for parallel sessions or panels to give opportunity to as many presentations as possible.



Arunava Banerjee



Brigid Nossal will speak on: Bringing group relations work alive in consulting to organisations.




